2024 SEC Filing Deadlines

Accelerated Filer

An accelerated filer is required to file its:

- Annual report on Form 10-K within 75 calendar days after its fiscal year-end
- Quarterly reports on Form 10-Q within 40 calendar days after its applicable fiscal quarter-end

These deadlines are extended if they fall on a weekend or a Federal holiday, or under limited circumstances if the issuer complies with Exchange Act Rule 12b-25.

An accelerated filer is defined as an issuer after it first meets the following conditions as of the end of its fiscal year: (1) has a public float of \$75 million or more, but less than \$700 million, as of the last business day of its most recently completed second fiscal quarter; (2) has been subject to public company reporting requirements for at least 12 calendar months; (3) has filed at least one annual report; and (4) is not eligible to use the requirements for smaller reporting companies under the revenue test of the "smaller reporting company" definition in Exchange Act Rule 12b-2.
